INTRODUCTION

Improving environmental sustainability and taking care of our planet is one of the cornerstones of our strategy. As part of sustainable operations, Olvi Group is aware of the significance of environmental issues in the brewing industry. We work to continuously reduce our environmental footprint. We want to contribute to the reduction of emissions in accordance with the Paris Agreement, with the objective of holding the increase in the average global temperature at 1.5°C. We focus on supporting the green transition and investing in sustainable energy and water solutions, as well as developing products that take into account environmental aspects. To combat climate change, we aim to have a carbon-neutral production in 2030 and a carbon-neutral value chain in 2040.

PURPOSE AND SCOPE

The purpose of Environmental Policy is to ensure that Olvi Group's business operations and business development managed taking into account environmental sustainability objectives and that all material impacts, risks and opportunities related to environment are managed in an appropriate way. Megatrends, stakeholders' expectations and the company's strategy are reflected in the objectives.

This policy complements the Group's Code of Conduct and other related Group policies. This policy applies to the management and employees in all Olvi Group companies, in addition to contract workers and visitors in the company's premises.

COMMITMENTS

For the implementation of the policy, Olvi Group is committed to respect relevant standards and initiatives, including the Science Based Targets initiative and Task Force on Climate-Related Financial Disclosures.

The management of environmental issues is based on certified and regularly audited environmental management systems. Most of our companies have ISO 14001 -environmental management system and/or ISO 50001 energy management system. The management and

development of environmental issues is realised through development programmes, action plans and target setting. Performance indicators, follow-up and responsibilities ensure a high standard of operations and development, as well as quick response to any deviations.

OBJECTIVES

We want to understand our impacts to protect and promote biodiversity both in own operations and in value chain. We focus on improving our operations with the following:

Combat climate change and strive for carbon-neutral production and value chain

- We reduce greenhouse gas emissions and manage transition risks in own operations and value chain to mitigate climate change. We adapt own operations and value chain to respond to the impacts posed by climate-related physical risks. We develop the understanding of financial opportunities and risks related climate change.
- We improve energy efficiency and reduce energy consumption. We focus on a gradual transition to renewable sources of energy.
- We may use greenhouse gas removals if there are not currently other ways available to remove greenhouse gas emissions in our operations.

Use water efficiently

- We minimize water withdrawals and water discharges through continuous development of efficient production processes. High quality water is used sustainably to ensure its sufficiency for other uses.
- We minimise the wastewater burden through water discharges by optimizing production processes and washing procedures.
- We develop ways to increase water recycling and reuse to reduce water withdrawals and water discharges.

Operate in line with circular economy

- In our operations, we avoid waste and keep materials in circulation for as long as possible with the following principles: 1) prevention, 2) reduce, 3) reuse; considering the

possibilities for repair, refurbish, remanufacture and repurpose, 4) recycle. After these, the next option for materials and products is other recovery. The final option is disposal.

- We increase share of material recycling, decrease landfill waste and hazardous material to minimum and manage hazardous materials properly.
- We increase the use of recycled, reusable and renewable materials and resources.
- We focus on reusing side streams as new resources.
- We take circular design into account in product development and product portfolio planning.
- We develop recycling schemes for packaging with local organisations.

Engage with stakeholders

- We ensure that employees are aware of environmental issues and do correct operating procedures.
- We choose responsible suppliers and consider environmental aspects in sourcing.
- We require environmental sustainability from all partners and collaborate to develop environmental issues.
- We engage with our stakeholders on environmental issues to ensure that their interests and views are taken into account.
