## Professional career

### Ponsse Plc, President and CEO since 2008

I started in my position just before the 2008 financial crisis. Due to the events of 2008, it was my responsibility to return the values of the Group to its roots, recovering from rapid growth. In hard times, it was also my duty to implement rapid changes in corporate structures and strategy, and to redevelop the organisation. Our success was excellent and the 2010s were a period of strong growth. Ponsse's net sales and number of personnel more than doubled, and a strong trend of internationalisation continued. The company's constant ability to reinvent itself has been efficient, and investments in product development have generated a sustainable competitive advantage. Ponsse is a company intensively driven by values, and our strong corporate culture is one of the most substantial merits in competition. Chairman of Ponsse's management team.

### Ponsse Plc, Factory Director 2006–2008

Responsible for Ponsse Group's industrial operations. Organisation included the Vieremä and Brazil factories, quality, IT, order processing and delivery configuration, totalling some 350 people. Projects included finalising a new production philosophy, improving the quality-producing ability, increasing the capacity and driving investments through.
